The Brecon and Radnor Express Classic Motor Show is in its inaugural year, the event is the idea of keen biker Andrew Powell from The Mountain Centre and has been jointly organised with Brecon Motor Club and The Brecon and Radnor Express Newspaper. We plan to have around 60 cars and 60 motorcycles on display with the aim to grow the event into an annual motoring event in the picturesque Brecon Beacons, celebrating the rich touring heritage of the area. The event aims to raise funds for the charity 'The Prince's Countryside Fund' which supports rural communities in times of difficulty, it aims to help fund projects that support the people who care for the countryside, to help improve service provision in rural areas and to help in educating people about the value of the countryside. The organising team are promoting the event on local radio stations such as Heart Radio and in the Brecon and Radnor Express and its sister newspapers within the Tindle Newspaper Group in addition to Motorsport Events and Shows that Brecon Motor Club is involved with.

The day will culminate in a scenic tour of approximately 40 miles around the Brecon Beacons (for those who wish to participate), returning to the Mountain Centre for a fun BBQ in the evening. Although admission and entry to the show is free of charge, there will be an entry fee for the Scenic Tour. Likewise, advance tickets will be required for the BBQ at a cost of £12.00 per person.

CONDITIONS OF EXHIBITORS ACCEPTANCE:

- Once inside the visitors centre grounds exhibitors are subject to the rules and regulations as laid down by the Management and the Show Organisers. The show opens to the public at 10.30 am, it is therefore a requirement that all exhibit vehicle are in location by 10.15am. Access to the show area will be available for setting up from 7.00pm on Saturday August 2nd up to 10.25am on Sunday 3rd August. Please note that there is no security on the show field overnight so equipment and vehicles are left entirely at the owners' risk. A complimentary mug of tea or coffee will be provided in the morning, on arrival along with the display space for your vehicle. All vehicles must remain on the showground until 4.00pm. NO unauthorised movement of vehicles is permitted during show. Any emergency need to leave at an earlier time must be agreed with the organisers and event marshals will be allocated to escort you off the display area should this become necessary. Vehicles entering and leaving the show area are restricted to a maximum of walking speed and in the interests of health and safety please ensure that the minimum amount of fuel possible is carried on or in the vehicle.
- It is the responsibility of the Exhibitors to ensure that all vehicles being driven on the showground have third party insurance cover. Road Traffic Act rules apply on site.
- All vehicles are accepted on condition that the authorities and the show organisers cannot be held responsible for exhibitors' negligence involving damage or injury to vehicles, property or persons. Similarly for loss or theft of vehicles, property, contents and equipment.
- Completion of this application form does not guarantee acceptance due to the limitation of exhibit space. All entries are entirely at the discretion of the organisers.
