IMPORTANT HEALTH & SAFETY INFORMATION

The aim of the organisers of the Castle Hill Car Festival is to provide an enjoyable and, above all, safe environment for exhibitors and the public to enjoy the vehicles on display.

Paramount in achieving that aim is to ensure that all exhibitors are aware of the possible hazards to themselves and the visiting public that exist in and around vehicles and moving machinery, and to assess and mitigate all risks as far as is reasonably possible.

You need to be aware that while you are attending the CHCF, you, and anyone assisting you in any capacity, have a legal responsibility under Health & Safety legislation to ensure that you have undertaken a risk assessment to safeguard your own health and welfare, and the safety of the visiting public. For example, this includes (but is not limited to) ensuring the safe handling and storage of fuel, the trip or shock hazard created by trailing cables and wires, plans in the event of fire or emergency, and the safe condition and operation of all engines, machinery and components.

If you are at all unsure, then you are strongly advised to seek out the H&S representative from CHCF who will help with the relevant advice.

INDIVIDUAL VEHICLE – CONDITIONS OF FESTIVAL ENTRY

1. The driver or exhibitor of the vehicle detailed in this application must be covered by a current Third Party Insurance Policy in respect of the vehicle concerned. This policy must cover participation as an exhibitor at an event such as the CHCF and must accompany the vehicle/driver/exhibitor and be available for inspection by the CHCF or its appointed agents.
2. Exhibitors, or those operating vehicles on their behalf, must ensure that the driver/operator concerned has a valid UK Drivers Licence for that type of vehicle.
3. No vehicle or any moving component must be allowed to operate when the exhibit is unattended. All unattended vehicles must be immobilized and any hazards removed.
4. There is to be no external storage of hazardous or combustible materials. Any such materials are to be secured within the vehicle concerned at all times.
5. All personal effects and items on display in connection with an exhibit are the responsibility of the exhibitor. CHCF do not accept any responsibility for the loss or damage of any such items.
6. The MAXIMUM speed at anywhere on the festival site is **5 mph**. The CHCF have empowered marshals and its agents to require the immediate removal of any persons/vehicles/effects for any breach of this rule.
7. Public and exhibitor safety is our paramount concern and so all exhibitors will act and operate their vehicles in strict accordance with the instruction of the appointed marshalls. Again, any person in breach of this rule will be removed from the CHCF with immediate effect.
8. Entry fees are non-refundable.
9. No refunds will be given in the event of cancellation for reasons of weather or other circumstances beyond our reasonable control.
10. Vehicles may only enter or depart the CHCF site by means of the allocated gate and between the allocated times. Strict adherence is required.
